## Know Everything About The Brycelyn Haughey Case

An lowa school district paraeducator and former female head volleyball coach who had intercourse with and sent naked photos to a 17-year-old student who had rear-ended her car was arrested. The 22-year-old **brycelyn haughey** was charged with four allegations of sexual exploitation by a school employee and one charge of distributing and displaying pornographic material to children.

Haughey was detained on December 15 as a result of an investigation by the Tama County Sheriff's Office and the Tama County Attorney. Haughey served as the head coach for the Green Mountain Garwin School District. She now faces a minimum sentence of 20 years in prison if found guilty. In this article we will discuss everything about brycelyn haughey and her case.

## Brycelyn met the student during an accident

During the 2020–2021 academic year, brycelyn haughey, was serving as the head volleyball coach at a school in the GMG district of rural lowa when she saw a 17 year old male student in the school's parking lot.

He bumped into her car, and they exchanged phone numbers since he was supposed to repair the damage he had done to Haughey's vehicle. The encounter, which happened in September 2020, was the start of a connection between brycelyn haughey and the student that lasted for several weeks and continued until December of that same year.

The student went to Haughey's house, where she was drinking alcohol with another female underage student. Before engaging in sexual activity with the teacher, the 17-year-old student joined them.

## Haughey reportedly flirted with the boy

Before he came to her house for the first time, she had been flirtatiously texting the student, and according to reports, she sent him at least one photo of herself in a naked condition. Brycelyn Natasha Haughey allegedly questioned the student about his age and whether he was a senior when they first met in the parking lot.

The affidavit stated: "[The student] stated that Brycelyn inquired how old he was, and he replied, '17," The student responded, "No, I'm a junior," when brycelyn haughey questioned if he was a senior. [The student] claimed that Brycelyn remarked, "Close enough," after that.

The student claimed that when the volleyball coach started sending him vulgar messages, he "went with it" and assumed that she was "joking around." In December, three months after Brycelyn and the student first met, Their sexual relationship ended.

## Haughey pleaded not guilty

Even though the legal age of consent in lowa is 16, persons in positions of authority can still be held accountable for sexual offenses if a minor under their supervision between the ages of sixteen and eighteen is involved.

A month after brycelyn haughey quit her job on September 23rd, the investigation began to take place in October 2021. Haughey was told not to speak to the victim after a no-contact order was issued on December 27. When Kym Stein became superintendent in July 2021, she declared that student safety was her primary focus.

Brycelyn Haughey appeared in court on February 10 with her attorney by her side and was officially charged. In relation to four charges of sexual exploitation by a school employee, the former paraeducator entered a not guilty plea.
